

## **\$99 EXCLUSIVE LICENSE AGREEMENT**

THIS AGREEMENT, made and enter into on **Fri, 26 Mar 2021 12:00:15 -0400** serves as a legally binding agreement between Pawel Tugeman, professionally known as Lazy Rida Beats (Licensor) and **Licensee** (Licensee). This agreement grants the Licensee EXCLUSIVE rights to the instrumentals named "**Sample Track Title**" (Instrumental). All Licenses are non-refundable and non-transferable.

### **MASTER RECORDING**

The Licensor hereby grants the Licensee the right to record vocal and instrumental synchronization to any or all parts of the Instrumental. The Licensee understands that their usage of the Instrumental is Unlimited and for Commercial Use. If the Licensee wishes to use the Instrumental in the Instrumental for additional compositions, the Licensee does not need to buy another License. The Licensee is allowed to edit the Instrumental.

### **PROFITABLE DISTRIBUTION**

The Licensee may distribute **UNLIMITED** units of the Master Recording for profitable use. ### **PERFORMANCE RIGHTS**

The Licensor hereby grants the License an EXCLUSIVE License to use the Master Recording in Unlimited for-profit, and non-profit performances, shows, or concerts.

### **SYNCHRONIZATION RIGHTS**

The Licensor hereby grants synchronization rights for unlimited music videos, unlimited monetized and non-monetized video streams (YouTube Vimeo, etc.). The Licensor also grants the Licensee synchronization rights for the Unlimited monetized and un-monetized streams on sites like Spotify, Rhapsody, etc.

### **AUDIO SAMPLES**

3rd party sample clearance is the responsibility of the Licensee.

### **OWNERSHIP**

Upon purchasing Exclusive Rights, the Licensor maintains ownership of the instrumental but is not able to resell it non-exclusively and/or exclusively,

## **CREDIT**

The Licensee must give production credit to the Licensor for any and all distributed material, including online platforms. This can be done in the title of the song, description, the CD Booklet, etc. The Licensee must give production credit to the Licensor as Lazy Rida Beats (for example, "prod. by Lazy Rida Beats" or "Beat by Lazy Rida Beats").
